INTRODUCTION

The "architect Simonetta Bastelli" cultural association aims to promote the culture of qualified landscape and the landscape in the collective commons, with a particular attention to the new generations, in an appropriate relationship between architecture and nature. For these reasons, it organizes the "Simonetta Bastelli" prize to be assigned to the best projects that enhance the relationship between architecture and nature in open spaces. The award is divided into two sections: professionals and training.

The aim of the contest, also in regard to Article 6 of the European Convention, is to "increase awareness among the civil society, private organizations, and public authorities of the value of landscapes, their role and changes to them" and to contribute to the "training and education" through proper and appropriate design methodology. The intent of the prize is to contribute to the training of professionals with a methodological approach focused on the quality of the landscape, reserving particular attention to younger generations, so as to promote issues concerning the quality of the landscape. An international jury will choose the best project for each session.

Art. 1 – THE COMPETITION

The "Architect Simonetta Bastelli" cultural association is holding a prize reserved to: professionals in the sector; enrolled with their degree thesis and University students.

Art. 2 – THEMES OF PROJECTS

The theme to participate in the award concerns the design of outdoor spaces, stressing in particular onto the relationship between architecture and nature. These spaces can belong to buildings (public or private) or autonomous (squares, avenues, parks, gardens, agro-forestry interventions, etc.).

Art. 3 – CONDITIONS OF PARTICIPATION

Both individuals and groups are allowed to participate to the competition. The competition is divided into two areas: professional and training.

Can participate in the first area all professional and designers that, regardless of enrollment in a professional register, have working to project on the subject.

In the second area can participate all new graduates and students. Can be submitted all Degree theses discussed by 31 July 2023 and the projects developed in study courses. New graduates and students of universities or similar schools can participate (individually or in groups); furthermore, can be presented works developed in the context of study courses can be presented, coordinated by a teacher.

It is not possible to participate in the competition with the same project presented for the previous editions of the prize, even if in a different category.

Art. 4 - REGISTRATION AND DOCUMENTS REQUIRED

Participation to the contest is free.

The participation is divided into two phases, with the same rules for all the categories.

- **FIRST PHASE:** before 21st of July 2023, for every category, it must be completed and sent (to the email address premio@simonettabastelli.com) the registration form model "A" – only .doc format -.

- **SECOND PHASE:** before September 9th, 2023 must be sent to the email address premio@simonettabastelli.com:

- the design drawings following the layout that will be provided to the participants in the competition: JPG format; RGB colors; dimensions A2 vertical (base 42.0 cm. height 59.4 cm.);
- a project report - only .doc format - of a maximum of 1,500 characters, spaces included;
- the form B of the reference category filled in with credits – only .doc format -.

The project will be excluded in case of lack of the required documentation. All materials received will not be returned.

Optionally, all participants can send a short horizontal movie in MP4 format. All the tables and films received will be included in the Architecture and Nature platform and will be visible for one year

Art. 5 - WINNERS

The projects will be analyzed by a jury who will select a maximum of 10 projects for each section; among these 10 projects, those deserving of awards and mention will be chosen.

A young winner (under 35) can also be identified for the first category "professionals". For the second "Training" area there will be a winner for the degree thesis and a winner among university students.

Art. 6 - JURY

The jury will be composed of representatives of public administrations, universities, professional bodies, specific associations and institutions, with the participation of international experts.

It will be composed of at least seven members and will be valid if the absolute majority of the members will attend.

The members of the jury will be able to meet and/or express their judgment electronically, deciding autonomously the methods of judgment.

The final decision of the jury is incontestable.

Art. 7 - AWARDS AND PUBLICATION

The awards will take place in autumn 2023. The date and place will be communicated promptly.

The winners, those mentioned and reported, will be promptly notified, to allow the re-throwing of the prize personally.

You will receive a plaque of special-diploma with some special prizes. There are no cash prizes. On request of the participants will be given a certificate of participation. The Competition reserves the right to display (in other places) and / or publish, the award information in the press, all the winning projects and report and all or part of the works presented.

Art. 8 - PRIVACY AND LIABILITY MATERIALS SENT

Each participant is responsible for the subject of their works, raising the organizers from any liability, including against any subjects depicted in the tables and / or work. The entrant must advise the concerned (people portrayed) in the cases and in the manner prescribed in Article 10 of Law 675/96 and subsequent changes with D.Lg. June 30, 2003 No. 196, and obtain consent to the dissemination of the same. In no case the images sent will contain information classified as sensitive.
